Orientation - All Staff

105 CMR 164.044 (B)(1)

The licensee must provide orientation to all staff, including clinical staff, qualified health care professionals, relief staff, interns, volunteers, and contract agency staff.

The licensee must have a written plan for the professional growth and development of all personnel. The plan must include orientation of employees regarding the following:
