This week, for Membership Monday, we are featuring May Institute, a vital organization dedicated to providing compassionate, evidence-based services for individuals who have developmental or intellectual disabilities or are living with brain injuries or neurobehavioral disorders.

Who is May Institute and What Do They Do?

Founded in 1955, May Institute is a nonprofit and a pioneer in the field of Applied Behavior Analysis (ABA). For nearly 70 years, the organization has provided compassionate, evidence-based services for individuals who are autistic, have developmental or intellectual disabilities, or are living with brain injuries or neurobehavioral disorders. With its corporate headquarters in Randolph, MA, May institute operates more than 140 service locations across the country including six specialized schools - five of which serve students with autism and one that serves individuals with brain injury and neurobehavioral disorders. Today, it stands as one of the largest providers of special education and services for individuals with special needs in Massachusetts and nationwide. May Institute's work is grounded in scientific research and best practices - and their longstanding commitment to clinical excellence, equity, and inclusion continues to shape their services and advocacy efforts today. Their work spans across:

- Early intervention services: targeted for children from birth to age 3, offering speech language therapy, physical and occupational therapy, service coordination, family support, and more.
- Autism and special needs schools: May institute operates one of the nation's largest networks of private schools focused exclusively on the students with autism and other special needs, offering full-day, year-round education that builds communication, social vocational, and academic skills.
- Adults services: these include day habilitation programs with integrated clinical supports (nursing, Ot/PT, speech), behavioral support, community involvement, and customizable residential programs.
- Global services: May offers consultation and training for professionals, families, and organizations around the world to improve service delivery and outcomes in the disability field.
