At the Providers' Council, we are proud to highlight the incredible work of our members who are making a difference in the human services sector. This week, for Membership Monday, we are featuring Martin Luther King Jr. Family Services, a vital organization dedicated to promoting well-being and strengthening families, youth, and communities across Western Massachusetts.

Who is MLK Family Services and What Do They Do?

Inspired by the values and legacy of Dr. King, MLKFS operates with the mission "to foster an environment where we nurture and empower the aspirations of individuals, families, and youth to achieve new realities of peace, social and economic justice, self-determination, self-actualization, and self-sufficiency."

Located in the Mason Square neighborhood of Springfield, MLKFS provides comprehensive services to underresourced communities in Hampden County. Their programming spans:

• Youth and Education:

Literacy-based after-school programs, the College Readiness Academy, the King's Kids After-School Program, and a tour of Historically Black Colleges and Universities (HBCUs) all support academic growth and access to higher education.

• Public Health and Wellness:

MLKFS leads health equity work through the Mason Square Health Task Force, prevention services, and teen leadership initiatives. Their on-site emergency food pantry supports individuals and families experiencing food insecurity and screens for SNAP eligibility. Additionally, they host a mobile food bank every 2nd and 4th Thursday from their 3 Rutland Street community center.

• Family Support Services:

The organization offers parenting support, financial coaching, income maximization assistance, and advocacy to help families thrive and stay together safely in their communities.

• Violence Prevention, Cultural Programming & Community Engagement:

Through culturally grounded programs, including sports and arts teams, MLKFS creates safe and empowering spaces for youth and community members to connect and grow.



When Did MLK Family Services Join The Providers' Council and Why?

A long-time member of the Providers' Council, Martin Luther King Jr. Family Services has consistently demonstrated its commitment to supporting vulnerable communities and advancing systemic change. In 2024, President and CEO Shannon M.
