Highlighting St. Mary's Center for Women and Children's Impact on the Community

At the Providers' Council, we are proud to highlight the incredible work of our members who are making a difference in the human services sector. This week, for Membership Monday, we are featuring St. Mary's Center for Women and Children, a longtime member organization based in Dorchester that provides shelter, supportive housing, and wraparound services to women, children, and families experiencing homelessness, poverty, and trauma. St. Mary's Center is helping families across Massachusetts achieve stability, opportunity, and long-term success.

Who is St. Mary's Center and What Do They Do?

Founded in 1933, St. Mary's Center for Women and Children (SMC) is a Dorchester-based, multi-service organization that provides life-changing support to some of Boston's most vulnerable populations. Each year, the Center serves more than 500 women, children, and families who are facing deep poverty, housing instability, and the effects of trauma.

What sets St. Mary's Center apart is its holistic, traumainformed model of care. The organization not only provides emergency shelter and housing but also delivers comprehensive wrap-around services that promote longterm stability and well-being. These services include behavioral health care, education and employment programs, parenting support, and early childhood education.

Their residential programs range from emergency family shelters to transitional and permanent housing, including their Young Parenting Living Program for pregnant and parenting teens and First Home, a transitional housing program that offers continued wrap-around support for up to two years. SMC also partners with local developers to offer permanent, affordable housing for families, ensuring continued access to supportive services.

Beyond housing, St. Mary's Center is committed to helping families break intergenerational cycles of poverty through on-site childcare, job readiness programs, and access to behavioral health and medical services through key partnerships with organizations like Boston Healthcare for the Homeless and UMass Boston.

By meeting families where they are and walking with them on the path to self-sufficiency, St. Mary's Center fosters longterm outcomes for two generations at a time, creating a more equitable and stable future for the communities they serve.




When Did St. Mary's Center Join The Providers' Council and Why?
